### **GODSHILL PARISH COUNCIL**

Minutes of the Ordinary meeting of the Parish Council held in the Village Hall, Godshill on Tuesday 11<sup>th</sup> June 2019 starting at 7.30 pm.

#### **Public Session:**

A parishioner reported that there had been two incidents in Godshill Wood whereby his cat had been shot by an airgun in daylight. Fortunately, the cat was not fatally hurt but had required treatment by a vet. He said that he had reported them to the police but advised residents to be vigilant.

A parishioner expressed concern about the proposed plans for re-designing the western pinch point and said that the dragons teeth on the verge approaching from the east may cause a visibility issue if the verge remained uncut and the dragons teeth in front of his cottage will be a hazard when taking any deliveries because that area was the only place in which vans/lorries could park to avoid blocking traffic flow around the pinch point.

Three parishioners gave lengthy reports and expressed their strong objections to and impact on their daily lives of the construction works and deliveries of mobile homes at Sandy Balls which frequently breached the conditions of the planning permission by working over the hours permitted and taking deliveries at weekends.

A parishioner asked that Sandy Balls be asked to cut the hedge on its boundary with the Southampton Road as it contained a number of brambles which were a hazard to pedestrians.

**Litter Warden:** Mrs Boyd said she had nothing to report.

**28.19** To receive apologies for absence: The Clerk advised that she had received an apology from Cllr Fell due to a work commitment and an apology from Cllr Emma Lane. Cllr Phillips was absent from the meeting.
