MINUTES 10.03.2020 GODSHILL PARISH COUNCIL

Minutes of the Ordinary meeting of the Parish Council held in the Village Hall, Godshill on Tuesday 10th March 2020 at 7.30 pm.

Present:

Cllr Cakebread - Chairman Cllr Fell (from 8.30 pm) Cllr Pomphrey Cllr Williams Cllr Woodward

Mrs Bev Cornish - Clerk Ten members of the public.

Public Session:

A member of the public spoke in strong support of the planning application for Broadhill Cottage.

A member of the public spoke in strong objection to the planning application for Godshill Wood Farm.

The applicant for the Godshill Wood Farm planning application spoke in support of his application and on the particular need for an additional barn on the site.

Litter Warden: Mrs Boyd reported that she was still collecting a lot of litter. She said it was in such a quantity that on a recent trip she had almost been unable to carry the heavy bag back to her house. As an additional concern, she alerted the Council to the amount of mud on the pavement from Crystal Hollow towards Sandy Balls which was causing a hazard to pedestrians.

164.19 To receive apologies for absence: The Clerk advised that she had received an apology from Cllr Phillips due to a work commitment abroad and a late apology from Cllr O'Brien due to a family emergency. She said that Cllr Fell had advised her that he was likely to arrive late at the meeting due to a work commitment. District Cllr Emma Lane had also sent her apologies. Cllr Cakebread proposed from the Chair and it was RESOLVED that the apologies and the reasons for them be noted.

165.19 Declarations of Interest:

a. To receive Declarations of Interest in respect of matters contained in this agenda, in accordance with the provisions of the Localism Act 2011 in respect of members and in accordance with the provisions of the Local Government Act 1972 in respect of officers:

No declarations of interest were received.

b. To consider any Dispensation Requests received by the Parish Clerk and not previously considered:

The Clerk confirmed that she had received no dispensation requests.

166.19 To resolve to approve the Minutes of the Ordinary meeting held on 11th February **2020:** Cllr Williams proposed, Cllr Pomphrey seconded and it was RESOLVED that the Minutes be approved and signed as a true record by the Chairman.

- 167.19 To resolve to refer any business raised by the public in public discussion, and any other matters or items of information from councillors, to a future meeting or to resolve to agree on any other action: With regard to the mud on the pavement near Crystal Hollow, Cllr Cakebread advised that the Clerk had given the Lengthsman the task of clearing the mud and overgrown areas on the pavement from Crystal Hollow to the Fighting Cocks when he visits the parish on Monday 16th March 2020.
- **168.19** To resolve to note Clerk's Report providing information on recent issues and work completed: Cllr Cakebread proposed from the Chair and it was RESOLVED that the Clerk's report be noted as follows:
- **81.19 Defibrillator Training:** The training was cancelled due to a personal issue with the trainer and it will be re-arranged.
- **108.19 Speed Indicator Devices:** The clips have been ordered and the SIDs have been configured. They will be installed on the poles once the clips arrive.
- **143.19: Fencing around the Southampton Road Cattlegrid:** This is still showing online as 'in progress'.
- **Litter Warden: Feb 20 Mtg:** Litter Bin at Cricket Pitch. The Clerk has failed to get a response from the Forestry England Officer despite several calls and messages left. She will continue to chase him
- **151.19: Boundary Commission Consultation:** The Clerk sent the parish's combined response with Hyde, Hale, Ellingham and Woodgreen parish councils.

169.19 Planning and Tree Work Applications:

At this point in the meeting Cllr Cakebread proposed from the Chair and it was RESOLVED that the meeting be opened to the applicants present to speak and respond to questions on their planning applications.

Application No. 20/00068 Broadhill Cottage, Broadhill Lane, Blissford – Replacement dwelling; retention of outbuilding with alterations: Following a lengthy question and answer session between the applicant and councillors and subsequent discussion, Cllr Pomphrey proposed, Cllr Woodward seconded and it was RESOLVED that Godshill Parish Council should leave the decision to officers under their delegated powers on the grounds that the application was contrary to policy SP16 of the NFNPA Local Plan. The Council would also ask the New Forest National Park Authority to consider enhancing the pre-application planning guidance it provides to applicants on non-designated heritage assets.

Application No. 20/00078 Godshill Wood Farm, Woodgreen Road, Godshill – Agricultural building: Following a question and answer session between the applicant and councillors and subsequent discussion, Cllr Pomphrey proposed, Cllr Woodward seconded and it was RESOLVED that Godshill Parish Council should to leave the decision to officers under their delegated powers as it was not able to determine whether this application met the requirements of DP50 of the NFNPA Local Plan in terms of functional need.

Application No. 20/00110 Ridgeway, Southampton Road, Godshill – Addition of pitched roofs to existing porch and extension; 3 no. Rooflights; alterations to doors and windows; cladding: Following a brief report from Cllr Williams, she proposed, Cllr Pomphrey seconded and it was RESOLVED that Godshill Parish Council should recommend permission for the application on the grounds that the proposal would enhance the dwelling and also have minimal impact on the Western Escarpment Conservation Area.

Application No. CONS/20/0125

Blissford Pool, Blissford Road, Blissford - Prune 1 x Monterey Cypress tree, Prune 1 x Lawson Cypress tree, Prune 1 x Holly tree, Prune 1 x Oak tree: Cllr Cakebread proposed from the Chair and it was RESOLVED that the decision on this application be left to the Tree Officer.

170.19 To consider a response to a consultation by the governors of the Forest Edge Learning Federation (which includes Hale and Breamore CE Schools) and Hyde CE on their proposal to create a Federation of the three schools with effect from 8 July 2020:

Following a brief discussion, Cllr Cakebread proposed from the Chair and it was RESOLVED that the Clerk should write a letter of support and encouragement to the governors for them to proceed with the creation of the federation of the three schools.

Cllr Cakebread proposed, Cllr Woodward seconded and it was RESOLVED that the Budget to Actual figures to 31st March 2020 be noted and the proposed virements be approved.

173.19 Outside Bodies and Representation:

North West Quadrant Meeting: Cllr Cakebread on a brief report on a recent meeting at which:

- There had been a presentation on volunteering and the funding available from the National Lottery to fund work with HCC Pathwatchers and other groups of volunteers to clear footpaths.
- The issue of litter in the National Park was discussed, particular issues relating to Whiteparish and a nearby HGV site.
- Paul Walton, Head of Environment and Rural Economy at the NPA gave a presentation on how it must plan for coping with emergencies in farming and nature post Brexit. At present HM Government payments are made to landowners for provision of "public goods" but this will cease by 2027. New schemes are being planned, to be piloted by 2022, for carbon capture planting (e.g. "right tree right place" as well as marsh, heath, etc.) The NPA is looking to work more closely with farmers immediately surrounding the Forest ("Green Halo"). He said the HLS scheme may be extended another 1 or 2 years to enable restoration of more river meanders, which with slow flow of water, improve habitat and reduce flooding lower down.

The Julian Glover Review on 70 years of National Parks is not favourable as they provide poor value for money because the decline in biodiversity has not stopped. The challenge is therefore for landowners to encourage diversification of wildlife, to increase income and improve conservation.

The issue of public transport within the Park was discussed because communities need private transport due to poor public transport provision. Free charging points for electric vehicles has been considered but thought expensive to install in remote areas.
