# Planning Application No. 21/00807 (AMENDED PLAN)

Paysanne, Godshill Wood - Application to vary condition 2 of planning permission 18/00262 for Dwelling; detached garage with office over; sewage treatment plant; details of lighting; demolition of existing dwelling and outbuilding to allow minor material amendment: Cllr Fell proposed from the Chair and it was RESOLVED that this item be deferred until the NPA has received an acceptable plan and the planning officer has sent the Council a briefing note. The Clerk advised that an extra meeting may need to be convened before May to consider the application.

#### Planning Application No. CONS/22/0148

Land At Brunes Purlieu, Purlieu Lane, Godshill - Prune 1 x group of Mixed tree species, predominately Oak trees: Cllr Fell proposed, Cllr Woodward seconded and it was RESOLVED that the application be left to the Tree Officer.

#### 190.21 Cyber Security Insurance

Following the Council's consideration that the quote of £319.20 from Arthur J Gallagher was expensive, the Clerk advised about an alternative option of using Dropbox for councillors and council documents to provide additional mitigation together with the purchase of an additional back up drive. Cllr Fell proposed, Cllr Woodward seconded and it was RESOLVED that the Clerk investigate further the setting up of Dropbox and the cost of back up drive for consideration at the next meeting. The Clerk was also asked to query the high cost of the quote with Arthur J Gallagher.
