Public Question Time

A member of the public asked whether the Council had been in consultation with the NFNPA on the new Partnership Plan. He said that there were a number of good things in it but he wondered whether there would be input from locals in its implementation.

Several members of the public raised the matter of not being consulted as a neighbour or previous responder to the planning application for Paysanne, Godshill Wood. They said that they understood that they should be consulted and that notices needed to be placed at the site but neither had been done.

A member of the public commented that as this was a Full Application, it should contain details of the property which it is replacing ie the bungalow that was on the site originally. There is no comparison on this application between what is proposed and the original bungalow.

A member of the public thanked the Council for getting the work to the footpath 772 in Godshill Wood progressed.

74.22 Business Raised During Public Question Time

Cllr Woodward reported that the North West Quadrant meeting was the mechanism by which the Council would have input into the implementation of the Partnership Plan as there would be a quarterly review of it and this would come to those meetings. He said he had asked how the cost of living crisis, Brexit, the Common Agricultural Policy and various plans which relate to the release of land for environmental projects and the money released for them. What they want to do and what they can do in terms of funding, means that there was quite a big hole in the funding.

On the matter of not being consulted on the planning application, Cllr Fell said that the Clerk would raise these matters in the Council's response to the application. The Council would also ask that the Planning Committee meeting be deferred until after the neighbours to the application had been consulted. The Clerk read out a response she had received from Steve Avery, the Executive Director for Planning at the NFNPA.

Cllr Fell advised the meeting that Claire O'Brien had resigned from the Council and he proposed from the Chair and it was RESOLVED that a letter of thanks be sent to her for the valuable work she had done as a councillor.

80.22 Planning and Tree Work Applications:

Planning application No 22/00695

Paysanne, Godshill Wood - Dwelling; detached garage with office over; sewage treatment plant; demolition of existing dwelling and outbuilding:

Following a brief discussion, Cllr Fell proposed, Cllr Cakebread seconded and it was RESOLVED to recommend Refusal for all the reasons previously stated in writing and in public at the July 2022 Planning Committee meeting which are that the proposed changes to the 'as built' dwelling do not mitigate the material planning harm it causes:

- To neighbours through loss of privacy and amenity
- Through its light pollution in this dark sky area
- To the character of the local area creating an obtrusive and uncharacteristically dominant presence within the landscape.

It does not comply with 9 areas of policy:

Policy SP16	a) Material harm to the Conservation Area, including views, trees and light pollution.
Policy SP6	Geological features completely changed by construction work.
Policy SP7	b) Massing and scale detract from the natural beauty of the National Park.
Policy DP2	 a) Inappropriate and unsympathetic in terms of scale, siting and layout. b) It does not respect the natural, built and historic environment and biodiversity. c) Individual trees and hedgerows removed, minimal appropriate new planting. d) Suburban-type wooden fencing without prior permission. e) Neighbour amenity impacted by visual intrusion, overlooking and light pollution f) Unacceptable adverse impacts from light pollution.
Policy SP17	Loss of local distinctiveness/character and suburbanising effect.
Policy DP35	Dwelling of greater floor space than the original, contrary to the permitted plans.
Policy DP36.	Floor space increased beyond policy limit. No exceptional circumstances
Policy DP37	Outbuilding granted retrospective permission for substantial increase in size, temporary residence, location change which exacerbates overlooking.
Policy DP18	 a) It harms the built and historic environment; d) The submitted plans have often been self-contradictory; environmental practices are questionable. e) It harms landscape setting (notably height, bulk and expanses of glazing).
